

MINUTES AND PROCEEDINGS OF A REGULAR MEETING OF THE BUTLER COUNTY BOARD OF SUPERVISORS HELD ON APRIL 1, 2014.

Meeting called to order at 9:00 a.m. by Chairman Rex Ackerman with members Tom Heidenwirth and Mark V. Reiher present. Also present were Engineer John Riherd, Economic Development Director Jeff Kolb, Chad Campbell, Campbell-Mellema Insurance and Fern Myers, Allison, Iowa.

Minutes of the previous meeting were read and approved as read.

Board met with Economic Development Director Jeff Kolb for a Revolving Loan Fund update.

Board met with Chad Campbell, Cambell-Mellema Insurance to discuss County insurance policies.

Board met with Engineer John Riherd to consider the following:

1) Award contract for bridge replacement project, BRS-C012(86)--60-12 (on T16 - Sec 22 Washington Twp). After discussion it was moved by Reiher, second by Heidenwirth to approve the recommendation of the Engineer and award said contract to PCI, Reinbeck, Iowa for \$495,400. Motion carried.

2) Road Closure Resolution for bridge replacement project, BRS-C012(83)--5F-12 (on T47 - Sec 27 Albion Twp). After discussion it was moved by Heidenwirth, second by Reiher to adopt the following:

**Resolution #798
Construction Road Closure**

WHEREAS, The Butler County Board of Supervisors is empowered under authority of the Code of Iowa to close roads or highways under their jurisdiction when necessary for construction, and

WHEREAS, a bridge replacement project, BRS-C012(83)--5F-12, requires that T47 (Sinclair Ave) from Hwy 57 north 1 mile to 320th Street be closed to thru traffic, and

WHEREAS, a detour route has been established and signed for thru traffic, and

WHEREAS, local traffic in the vicinity of the construction project will be maintained outside of the construction limits of project BRS-C012(83)--5F-12,

NOW THEREFORE BE IT RESOLVED by the Butler County Board of Supervisors that the above described roads and bridges be closed and proper signs be erected for the duration of the construction project as determined by the County Engineer.

BE IT FURTHER RESOLVED that upon completion of the construction work, as determined by the County Engineer, the road shall be opened to the traveling public without further action of this board.

3) Temporary Stop Sign Resolution for 320th Street/Ridge Ave and Tanner Road/Ridge Ave. After discussion it was moved by Reiher, second by Heidenwirth to adopt the following:

**Resolution #799
Temporary Stop Signs**

WHEREAS, The Butler County Board of Supervisors is empowered under authority of Section 321.255 of the Code of Iowa, upon the basis of an engineering and traffic investigation to erect traffic control devices, and

WHEREAS, a bridge replacement project, BRS-C012(83)--5F-12, located on T47 (Sinclair Avenue) approximately 0.1 mile North of IA Hwy 57 requires County Route T47 to be detoured, and

WHEREAS, a detour route has been established and signed for thru traffic, and

WHEREAS, motorists failing to follow the designated detour route will likely cause an increase in traffic on surrounding local roads, and

WHEREAS, traffic safety would be better served if a stop condition was established for 320th Street at its intersection with Ridge Avenue for traffic approaching the intersection from the west, and

WHEREAS, traffic safety would be better served if a stop condition was established for Tanner Road at its intersection with Ridge Avenue for traffic approaching the intersection from the east,

NOW THEREFORE BE IT RESOLVED by the Butler County Board of Supervisors that a stop condition be established for 320th Street at Ridge Avenue and that a stop condition be established for Tanner Road at Ridge

Avenue for the duration of Project BRS-C012(83)--5F-12 and that the proper signs be erected, as determined by the County Engineer.

BE IT FURTHER RESOLVED that once the temporary traffic control is no longer warranted, as determined by the County Engineer, the temporary stop sign shall be removed without further action of this board.
