

**MINUTES AND PROCEEDINGS OF A REGULAR MEETING OF THE BUTLER COUNTY BOARD OF SUPERVISORS HELD ON SEPTEMBER 30, 2014.**

Meeting called to order at 9:00 a.m. by Chairman Rex Ackerman with members Tom Heidenwirth and Mark V. Reiher present. Also present were Sheriff Jason Johnson, Emergency Management Coordinator Mitch Nordmeyer and Fern Myers, Allison, Iowa.

Minutes of the previous meeting were read and approved as read.

Board reviewed bids for Courthouse security measures. Also present were Engineer John Riherd, Recorder Janice Jacobs and Facilities Manager Bill Miller. Facilities Manager Bill Miller presented the Board with three bids for panic button installation and added security for interior office doors. Board rejected installation of any panic button system, as Sheriff Johnson and Emergency Management Coordinator Nordmeyer asserted that the present system of notification via the telephone was sufficient. ALICE active shooter training for all Courthouse employees is tentatively set for the week of October 13<sup>th</sup>. Following further discussion, it was moved by Reiher, second by Ackerman to accept a bid from System Services, LLC, Waterloo, Iowa for security systems for interior office doors at a cost of \$8,315. Motion carried.
