

**MINUTES AND PROCEEDINGS OF A REGULAR MEETING OF THE BUTLER COUNTY BOARD OF SUPERVISORS HELD ON MAY 5, 2015.**

Meeting called to order at 9:00 a.m. by Chairman Tom Heidenwirth with members Rex Ackerman and Rusty Eddy present. Also present were Engineer John Riherd, Sheriff Jason Johnson, Zoning Administrator Mitch Nordmeyer, Mark Reiher, New Hartford, Iowa and Fern Myers, Allison, Iowa.

Minutes of the previous meeting were read and approved with a correction to paragraph 6 striking sentence regarding the depth Neiman Construction was digging for said project.

Moved by Heidenwirth, second by Ackerman to approve Road Closure Resolution as follows:

**RESOLUTION #828  
CONSTRUCTION ROAD CLOSURE**

WHEREAS, The Butler County Board of Supervisors is empowered under authority of the Code of Iowa to close roads or highways under their jurisdiction when necessary for construction, and

WHEREAS, a bridge replacement project, BROS-C012(88)--5F-12, requires that Yale Ave from County Route C33 (190<sup>th</sup> Street) north 1 mile to 180<sup>th</sup> Street be closed to thru traffic, and

WHEREAS, a detour route has been established and signed for thru traffic, and

WHEREAS, local traffic in the vicinity of the construction project will be maintained outside of the construction limits of project BROS-C012(88)--5F-12,

NOW THEREFORE BE IT RESOLVED by the Butler County Board of Supervisors that the above described roads and bridges be closed and proper signs be erected for the duration of the construction project as determined by the County Engineer.

BE IT FURTHER RESOLVED that upon completion of the construction work, as determined by the County Engineer, the road shall be opened to the traveling public without further action of this board.
