Meeting called to order at 9:00 a.m. by Chairman Tom Heidenwirth with members Rex Ackerman and Rusty Eddy present. Also present were Engineer John Riherd and Fern Myers, Allison, Iowa.

Minutes of the previous meeting were read and approved as read.

Board did not meet with Shawna Lebeck.

Moved by Heidenwirth, second by Eddy to approve the recommendation of County Social Services Human Resources Committee and approve Sarah Janssen as Butler County Coordinator of Disability Services starting July 1, 2015 at a salary of \$43,000. Motion carried.

Board set date and time for proposed FY15 County Budget Amendment for June 16, 2015 at 9:30 A.M.

Moved by Eddy, second by Ackerman to accept the recommendation of Engineer Riherd and award the T-16 Pipe Extension contract to the low bidder, Cole Excavating, Greene, Iowa for \$142,820.70. Motion carried.
