MINUTES AND PROCEEDINGS OF A REGULAR MEETING OF THE BUTLER COUNTY BOARD OF SUPERVISORS HELD ON JUNE 12, 2018.

Meeting called to order at 9:00 a.m. by Chairman Greg Barnett with members Rusty Eddy and Tom Heidenwirth present. Also present were Zoning Administrator Misty Kroeze, County Attorney Greg Lievens, Collections Specialist Julian West, Jake Huff and Kyle Helland, Cedar Falls, Iowa.

Minutes of the previous meeting were read and approved as read.

Board held a public hearing on the request by Stephen Koop to subdivide 92 acres on Beaver Valley Road, New Hartford, Iowa. Present were Zoning Administrator Misty Kroeze, County Attorney Greg Lievens, Collections Specialist Julian West, and Jake Huff and Kyle Helland, Cedar Falls, Iowa. Auditor reported no oral or written comments received. At the close of the public hearing it was moved by Heidenwirth, second by Barnett to approve the following:

RESOLUTION #901

RESOLUTION APPROVING THE "KOOP'S MINOR PLAT", BY BUTLER COUNTY, IOWA

WHEREAS, Koop's Minor Plat to Butler County, Iowa, containing four (4) parcels, has been submitted for approval to the Butler County Board of Supervisors consisting of the following described real estate:

WHEREAS, the Butler County Board of Supervisors find that the Koop's Minor Plat would be advantageous to Butler County, Iowa, and

Resolution #902 Construction Road Closure

WHEREAS, The Butler County Board of Supervisors is empowered under authority of the Code of Iowa to close roads or highways under their jurisdiction when necessary for construction, and

WHEREAS, a construction project, L-HPC-0(1)--73-12 requires that Butler County Route T64 from C13 north1 mile to Floyd Line Street be closed to thru traffic, and

WHEREAS, local traffic in the vicinity of the construction project will be maintained outside of the construction limits of project L-HPC-0(1)--73-12, and

WHEREAS, thru traffic is encouraged to follow signed detour route, and

NOW THEREFORE BE IT RESOLVED by the Butler County Board of Supervisors that the above described road is to be closed and proper signs erected for the duration of the construction project as determined by the County Engineer.

BE IT FURTHER RESOLVED that upon completion of the construction work, as determined by the County Engineer, the road shall be opened to the traveling public without further action of this board. The vote thereon was as follows:
