

**MINUTES AND PROCEEDINGS OF A REGULAR MEETING OF THE BUTLER COUNTY BOARD OF SUPERVISORS HELD ON OCTOBER 4, 2011.**

Meeting called to order at 9:00 a.m. by Chairman Karl Nelson with members Mark Reiher and Tom Heidenwirth present. Also present was Fern Myers, Allison, Iowa.

Minutes of the previous meeting were read and approved as read.

Moved by Heidenwirth, second by Reiher to set a Public Hearing on a proposed amendment to the FY12 County Budget for Tuesday, October 25, 2011 at 9:30 a.m. Motion carried.

Board reviewed the Quarterly Reports of the Auditor and Sheriff and ordered them placed on file.

Board acknowledged receipt of Manure Management Plan Annual Updates for M&M Construction, Brinkman Hog Farms, Klingenberg Site, Retexe LLC, and Steve Schmidt.

Board held a Public Hearing on the 2-Mile Fringe Area Policy Agreement between Butler County, Grundy County and the City of Parkersburg. Zoning Administrator Steve Busse, County Engineer John Riherd, and Parkersburg City Clerk Christopher Luhning were present. Also present were Fern Myers, Allison, Eldon Peters, Joe Simon, Miles Humphrey and Kate Humphrey, all of Parkersburg.

Auditor Holly A. Fokkena reported she received no written or oral comments. Busse added he also received no written or oral comments voicing either approval or opposition to the Agreement.

Busse indicated that the Butler County Planning & Zoning Commission had reviewed the Agreement and recommended it be approved by the Supervisors. He informed those present that the proposed Agreement would require any future subdivisions located within the designated area meet specific design standards as established by either the Counties or the City depending on which of 3 zones within the 2-mile fringe area the property was located to provide orderly growth and development within the area. City Clerk Luhning stressed that this agreement is being requested to increase communications between the three governments pertaining to potential subdivisions. He also indicated this agreement has no impact on taxation. Upon the close of the Public Hearing, it was moved by Heidenwirth, second by Reiher to adopt said Resolution.

**RESOLUTION #742**

A RESOLUTION AUTHORIZING THE CHAIRMAN OF THE BOARD OF SUPERVISORS TO SIGN AND THE COUNTY AUDITOR TO ATTEST TO THE TWO-MILE FRINGE AREA POLICY AGREEMENT BETWEEN BUTLER COUNTY, IOWA; GRUNDY COUNTY, IOWA; AND THE CITY OF PARKERSBURG, IOWA ESTABLISHING POLICIES FOR DEVELOPMENT OF LAND WITHIN THE TWO-MILE EXTRATERRITORIAL AREA OF PARKERSBURG WITHIN BUTLER COUNTY.

WHEREAS, two (2) or more local governments enabled under Section 354.9 and Chapter 28E of the Code of Iowa to enter into agreements to cooperate for the mutual advantage of the governments involved; and

WHEREAS, Butler County deems a land use policy agreement with the City of Parkersburg for orderly growth and development within the two (2) mile extraterritorial jurisdiction of Parkersburg within Butler and Grundy Counties, to be to the mutual advantage of Parkersburg, Butler County, and Grundy County.

NOW THEREFORE BE IT RESOLVED, that the Board of Supervisors of Butler County hereby authorizes the Chair of the Board of Supervisors to sign and the County Auditor to attest to the attached 28E Agreement between Butler County, Grundy County, and the City of Parkersburg establishing land use policies for the two (2) mile extraterritorial jurisdiction of Parkersburg in Butler County.

After discussion, it was moved by Reiher, second by Heidenwirth to adopt the following Resolution Implementing Fees for Medical Examiner Investigators.

**RESOLUTION NO. #743**  
**Medical Examiner Fees**

WHEREAS, Section 331.802(2) of the Code of Iowa states it is necessary for the Board of Supervisors to establish a fee to compensate physicians acting as Medical Examiner on behalf of Butler County, Iowa, and

WHEREAS, it has become increasingly difficult to obtain the services of a Medical Examiner in Butler County, Iowa, the Board of Supervisors desires to utilize Medical Investigators in addition to Medical Examiners.

THEREFORE BE IT RESOLVED by the Butler County Board of Supervisors that effective immediately, the rate of compensation per service call for a Medical Examiner's preliminary examination and report as provided by said Section 331.802(2) to any location in Butler County, Iowa, will be \$175.00 per call, plus actual expenses. Any claims for reimbursement of mileage expenses shall be paid at the current IRS reimbursement rate.

BE IT FURTHER RESOLVED that effective immediately, the rate of compensation per service call for a Medical Investigator shall be as outlined in the previous paragraph except said fee shall be split \$125.00, plus actual expenses, to the Medical Investigator and \$50.00 to the Medical Examiner who prepares the report.

BE IT FURTHER RESOLVED that the County shall pay for said services upon receipt of timely filed invoices. All invoices must show the date and specific location of the call and be submitted within 90 days of the actual service to the Butler County Auditor's office.
